- 2. Approval of Minutes The minutes were presented and voted on without dissent.
- **3. Legislation of Interest.** Greg and Catherine shared information and updates on the status of current legislation which may affect CCA. Greg advised he would provide these updates to the members and all agreed it would be advantageous for CCA to take a proactive role in legislation affecting the Cannabis industry.
- **4. Committees Calendar.** Greg advised the Regulatory and the Tax committees have been formed and meetings set on the calendar. It was agreed a Legislative committee should be formed and all board members will email Greg any suggestions for members for this committee.
